Q2 2022	Tuesday 18 th January 2022	National or Local station with identical TSA to a commercial station on the survey
Q3 2022	Monday 21 st March 2022	National, Regional, Local AM, FM or Digital entry date
Q4 2022	Monday 4 th July 2022	National or Local station with identical TSA to a commercial station on the survey

***Due to Covid 19, these dates and the measurement service provided by RAJAR are subject to review due to ongoing recruitment developments.**

- National/National Digital stations can join at any quarter throughout the year
- A station with an identical TSA (total survey area) to a commercial station already on the survey can join at any quarter
